Commissioner Townsend asked if a set of talking points on PLANiTULSA could be prepared for Commission members. Mr. Sharrer agreed to draft talking points prior to the public hearing.

Commissioner Curtis requested that the Commission consider writing a letter to the Diocese of Tulsa expressing those views and encouraging the preservation and resale of the properties.
