Historic Preservation Permit Subcommittee Review Dates: February 4, 2021;

Applicant: Patricia D. Berry

Proposal:

1. Construction of residence

Staff presented its report, noting that the applicant had provided the additional documentation requested by the Historic Preservation Permit Subcommittee. Commissioner Grant reported that, during the first review of the application, the Historic Preservation Permit Subcommittee was impressed with the direction of the project and requested the representation of a water table on each facade. Commissioner Turner reported that, during the second review of the application, the subcommittee requested an elevation and site plan showing the scale and outline of the residence in comparison with the adjacent residences. Commissioner Turner observed that the two-story section of the residence was located at the rear to create the appearance of a one-story structure when viewed from the street and noted that all residences in Barnard Trace were constructed at a considerably higher elevation than those in the neighborhood. Commissioner Turner reported that Matthew D. McAfee, Neighborhood Representative for the Yorktown Historic Preservation Overlay District, had participated in the review and had requested the addition of fenestration to the east façade. Commissioner Reeds indicated approval of the proposal. Commissioner Sanders commented that he was pleased with the cooperation from the owner and her architect during reviews by the Historic Preservation Permit Subcommittee and expressed his opinion that the residence would provide an appropriate transition between Barnard Trace and the Yorktown Historic District. Commissioner Sanders complimented Neighborhood Representative McAfee for his contribution, adding that the applicant was willing to accommodate Mr. McAfee's request that the stucco not be white. Commissioner Townsend agreed that the residence would be a nice transition between its adjacent residences. The applicant stated that she wished to be considerate of her neighbors on both sides of the site.

As there was no further discussion, Commissioner Reeds made a motion to approve the application. The motion was seconded by Commissioner Grant and approved unanimously.
