B. Actionable Items

1. HP-0687-2025 / 1602 S. Lewis Ave. (Yorktown)

Applicant: Steven Jones

Proposals:

1. Replacement of windows

Commissioner Ellington reported that discussions had taken place regarding the potential repair or replacement of the windows. He indicated that the applicant's proposal for window replacement was in accordance with the established guidelines. He mentioned that they recommended the approval of the replacement of the windows. Mr. Jones remarked that they had selected specific windows designed to closely resemble the existing ones. He pointed out that all the trims would be replaced and constructed to match the current design precisely. Commissioner Sanders noted that he had encountered windows in significantly worse condition than those currently presented. He expressed his belief that the windows could be repaired and inquired whether the applicant had considered the option of repair instead of replacement. Mr. Jones affirmed that he typically opts for repair before considering replacement. He expressed concern regarding the windows, particularly where the sashes meet the side rails, as they are rotted, preventing the preservation of all the side frames due to water damage. Commissioner Grant mentioned that during the subcommittee meeting, they initially recognized the necessity of replacing the windows, leading to their conclusion to recommend approval for the replacement. Commissioner Sanders stated that even when windows are replaced wood for wood, the original glazing, muntins, and old growth lumber are lost. Mr. Jones expressed that he believed the windows are just beyond the point of being salvageable.

Commissioner Ellington made a motion to approve the application as presented. The motion was seconded by Commissioner Turner. The motion passed.
